



Capital management company for digital assets



With the acquisition of Kapilendo Custodian AG in 2021, one of the first crypto custodians with permission to hold crypto assets, belongs to our group. Through its in-house custodian, the bank offers services in the regulated custody of cryptocurrencies, tokens, crypto securities and crypto fund shares.

Crypto securities registry

We were one of the first traditional financial institutions to receive preliminary permission from the German Federal Financial Supervisory Authority to start crypto securities registry business.
